

### P.O.A. OF STERLING SHORES, INC. CERTIFICATION OF ADOPTION OF AMENDMENT

WHEREAS, P.O.A. of Sterling Shores, Inc. (the "Association") constitutes a property owners association under the provisions of Chapter 209 of the Texas Property Code (the "Code");

WHEREAS, Paragraph 10.06, Section X of the Declaration of Covenants, Conditions and Restrictions for Sterling Shores (the "Declaration") provides that the Declaration may be amended or changed, in whole or in part, at any time by the written agreement or by signed ballots voting for such amendment, of not less than two-thirds (2/3rds) of all of the Owners of the Subdivision; and

WHEREAS, the Board of Directors of the Association (the "Board") called a vote by the Owners to amend the Declaration as to commercial activity and short-term rentals and said vote passed;

**NOW, THEREFORE,** the Board hereby adopts this Certification of Adoption of Amendment (the "Certification"), as set forth below:

### AMENDMENT TO DECLARATION

No business or commercial use or activity may be conducted within the Subdivision. Rental of any residence, tract and/or lot for a period of six or more months shall be permitted and shall not be deemed a commercial usage. Short term rental of any residence, tract and/or lot for a period of less than six months, including specifically rental as an Airbnb, Vrbo, or other short-term rental, shall not be permitted and shall be deemed a commercial usage. However, Owners may conduct their private computer, bookkeeping or clerical activities for their own business or work remotely with other offices so long as such business is in compliance with the Declaration of Covenants, Conditions and Restrictions for Sterling Shores and does not interfere or degrade the peace and quiet of the Subdivision. In any event, no use shall be permitted which would violate the quiet enjoyment of any other property within the Subdivision.

Owners shall submit to the P.O.A. of Sterling Shores, Inc. Office contact information for any lease or rental applicant, including the name, mailing address, phone number, and e-mail address of each person who will reside at a property in the Subdivision under lease; and the commencement date and term of the lease as provided in Section 209.016, Texas Property Code. No sub-leasing of property by an approved tenant is allowed. Tenants in possession shall abide by all restrictions, as amended and supplemented, of the P.O.A. of Sterling Shores, Inc. Any fines incurred on the property by a tenant will be the responsibility of the Owner.
